Recommendation



- The general recommendation identified was to create LGBTQIA+ supports for teens and young adults. At the time the recommendation was identified, we knew we needed more research to specify what that would look like, leading to listening sessions and implementation of the recommendations of those in attendance. GSAs within the school districts, changes to school policies, community support, and identification of LGBTQIA+ supportive resources and businesses were the recommendations.
- When recommendation was identified: December 2022
- When recommendation was implemented: December 2022

Background

First SOFR year only overdose fatalities were reviewed because of funding

All fatalities are reviewed of residents and incidents within our county

2023 Year-end Report Data

50 percent of female decedents identified as LGBTQIA+ 12.5 percent of total decedents identified as LGBTQIA+

The state percent of LGBTQIA+ adults is 4.5%


Space Considerations

- Established attendee-led safe space expectations
- Held the sessions in a location known to be LGBTQIA+ youth-friendly
- Included openly LGBTQIA+ individuals to co-lead the discussion

What We Heard

Our attendees identified the same struggles as identified in the Gay, Lesbian, and Straight Education Network (GLSEN) 2021 National School Climate Survey

- Hearing biased remarks in school
- Feeling unsafe in school
- Chronic absenteeism due to safety reasons
- Experiencing harassment and assault in school
- Experiencing discriminatory practices and policies at school



ABOUT

Riverside Overdose Data to Action (RODA)

- Established in 2019 through a grant from the Centers for Disease Control and Prevention, National Center for Injury Prevention and Control
- Sharp increase in overdose fatalities; trends depicted a 10-year increase in overdose deaths, emergency department visits, and hospitalizations

DEMONSTRATED A NEED FOR RIVERSIDE COUNTY PUBLIC HEALTH TO

- Enhance the surveillance of overdose morbidity and mortality in Riverside County
- Use data to guide overdose prevention efforts
- Create more responsive and collaborative prevention efforts to address the upstream causes of substance use disorders and overdose





- During each OFR meeting
 - Data trends are presented and utilized to facilitate discussions

Polysubstance: Fentanyl and Methamphetamine	93	297	+204
Latinx	212	331	+119

Latinx Overdose Death Trends

Drug Type	2020	2022	Percent
Cocaine	24	40	67%
Fentanyl	104	228	119%
Methamphetamine	111	188	69%
Rx Opioid (no fentanyl)	19	20	5%
Fentanyl and Methamphetamine	30	107	257%
Total	212	331	56%



Identifying the Recommendation



- Getting families to meet loved ones where they're at!
 Stigma reduction

 - Education
 - Awareness

RECOMMENDATION

Increase outreach efforts among the Latinx/Spanish-speaking population by August 2023 to decrease overdose fatalities among this population through the use of Promotores

Implementing the Recommendation



 Developed partnerships with organizations with well-established Community Health Worker, or Promotores, programs





• Promotores – conduct community outreach and deliver substance use prevention and harm reduction education



• Leaders from the communities that we wanted to reach – Latinx

- Amazing ability to connect
 - Shared language, culture, and experiences of their communities
- Trusted members of their community
 - Reduce barriers to health education and services
- Resulting in better health for more individuals, families, and communities!



Implementing the Recommendation

- Partnered with Desert Healthcare District & Foundation to conduct outreach in the desert region
 - Large Spanish-speaking population
 - High number of overdoses





Community Impact Highlights

Visión y Compromiso

- Reached 3,584 people via outreach
- **566 participants** in their harm reduction workshops

El Sol

• **51 participants** trained on harm reduction

FACES OF FENTANYL

- Riverside County Fentanyl Task Force
- Spanish commercials during the World Cup

Desert Healthcare District & Foundation

- Trained 154 community members on harm reduction
- 181 community members reached via outreach events, where 144 Narcan boxes were distributed

- · Facilitate virtual meetings and workshops




OFR Mentor Site Opportunities
